The Waikoloa-Wind Settlement with Castle & Cooke Homes Hawaii, Inc. and Castle & Cooke Waikoloa, LLC about the wind resistance design in Kikaha at Wehilani and Makana Kai at Wehilani homes has received final approval from the Court.

Payment will be withheld for Forms W-9 that are incomplete, inaccurate, or disputed (e.g., the name on the Form W-9 differs from the name on Waikoloa-Wind Class Members identified upon Final Judgment) pending resolution of those disputes. You will be notified via mail if additional information is needed to prove you were the owner of the Waikoloa-Wind Class Structure on the date of Final Judgment before any payment will be issued for that Waikoloa-Wind Class Structure.
